ARTICLES OF INCORPORATION

- Article I. The name of this corporation shall be SAFE AND SECURE RESPITE CARE, INC. This corporate entity is being created as a not for profit company. This corporate entity is compliant with Chapter 617 of the Florida Statutes and Section 501(c3) of the Internal Revenue Code.
- Article II. The principle place of operation and the mailing address for Safe and Secure Respite Care, Inc. is 3091 Skyline Drive Crestview, Florida 32539.
- Article III. Safe and Secure Respite Care, Inc. has been created for the humane and charitable purpose of providing quality adult health care and adult daycare to indigent residents of Northwest Florida.
