WHEREAS, Section 12 of the Articles provides that the Articles may be amended upon the recordation of an instrument executed by the Community Association upon (i) approval of twothirds (66 2/3%) of the Board; and (ii) seventy-five percent (75%) of all of the votes in Association; and

WHEREAS, the amendments were adopted by at least seventy-five percent (75%) of the total voting interests with each proposed amendment receiving at least two hundred fifty-six (256) Member votes in favor of each amendment; and

NOW, THEREFORE, be it certified and affirmed by the HIGHGATE AT KINGS RIDGE NEIGHBORHOOD ASSOCIATION, INC., that the amendments to the Articles were adopted by the requisite vote of the Neighborhood Voting Members as aforedescribed.
