The undersigned acting as Incorporator, for the purpose of forming a Corporation under the provisions of Chapter 617 of Florida Statutes, the Florida Not For Profit Corporation Act, Hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME AND DURATION

The name of this corporation shall be: LEON COUNTY VOLUNTEER CENTER, INC. hereinafter referred to as: LCVC, This corporation is non-stock and is to exist perpetually commencing at the time of filing the articles with the Department of State.

ARTICLE II PRINCIPLE OFFICE

The principle place of business of this corporation shall be: 1350 E4 East Tennessee Street, #246, Tallahassee, Florida 32308 and the mailing address shall be the same.

ARTICLE III PURPOSE (E)

Pursuant to section 501(c) (3), Section 170(c) (2) of the Internal Revenue Code and Chapter 496 of Florida Statute, This Corporation is organize to serve the community specifically for charitable, educational and philanthropic purposes.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

Upon dissolution, all of its remaining assets after payment of debts, cost and expenses, shall be distributed to other non-profit companies under 501 (c) (3), for public purposes and for charity. All other powers are as set fourth in the bylaws.

ARTICLE VII AMENDMENT AND INDEMNIFICATION




