Pursuant to F.S.S. 617.1402 and 617.1403 of the Florida Statutes, The Borland Center, Inc., Inc., a Florida not for profit corporation, hereinafter (the "**Corporation**"), submits the following articles of dissolution:

1. The name of the Corporation is The Borland Center, Inc.; and
2. The effective date of dissolution is June 30<sup>th</sup>, 2016; and
