ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is PRIMERA IGLESIA BAUTISTA HISPANA de INDIANTOWN, INC.

ARTICLE II

The purpose of this corporation is to engage in and support evangelization of our Christian Faith.

ARTICLE III

The government of this corporation is vested in the body of believers who constitute its members.

ARTICLE IV

MEMBERSHIP

The qualification for membership and the manner of admission, discipline and termination shall be as provided in the By-laws.

ARTICLE V

The initial principal office and mailing address of the corporation shall be at:

4995 Springfield Drive, West Palm Beach, FL 33406

ARTICLE VI

OFFICERS AND TRUSTEES

The officers of the corporation shall be a President and a Secretary, who shall also serve as Trustees. The Trustees shall have the duty to pass appropriate Resolutions authorizing the execution of legal instruments by the officers of the corporation identified in such Resolutions by the Trustees. The annual

election of Trustees shall take place in accordance with the provisions of the By-Laws all corporate powers shall be exercised in the manner and according to the procedures as provided in the By-Laws and subject to the authority of the members as provided therein. The Trustees shall be elected by the members for the terms and according to the procedures provided in the by-laws.

ARTICLE VII

BY-LAWS

The By-laws shall provide for the procedure by which persons become members, for discipline and termination of membership, for the selection and duties of the Officers and Trustees. The By-laws shall also provide for preparation of a budget, appropriate accounting procedures, and establish the fiscal year of the Church. Initial adoption of the By-laws shall be in the same manner as provided for amendments to these Articles of Incorporation. amendments to the By-laws shall be as provided in the By-laws.

ARTICLE VIII

AMENDMENTS

Amendments to these Articles of Incorporation may be made at any regular business meeting of the members of the corporation, provided that each amendment shall have been presented in writing at a previous regular or special meeting or by mail to each member. The proposed amendment to be adopted must pass by a vote of at least two-thirds (2/3) of all members present and entitled to vote. Only those members in attendance in person or by proxy at the meeting at which the vote to amend is taken shall be entitled to vote thereon.

ARTICLE IX

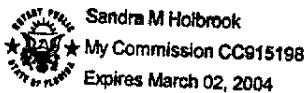
