**ARTICLES OF INCORPORATION
OF
GREATER NEW MOUNT CARMEL MISSIONARY BAPTIST CHURCH, INC.
A Corporation not-for-profit**

The undersigned, in accordance with the provisions of section 617, Florida Statutes, hereby make, subscribe and file these Articles of Incorporation for the purpose of forming a corporation not-for-profit.

ARTICLE I

The name of the corporation shall be: Greater New Mount Carmel Missionary Baptist Church, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 2450 Northwest 22nd Street, Fort Lauderdale, Florida 33311.

ARTICLE III

The purpose and objectives for which this corporation is organized and the general nature of the business to be transacted shall be to:

1. Teach and proclaim the philosophy, religion and doctrine of the Baptist Church.
2. Advance spiritual growth and enlightenment, moral and personal purity among its own members and people of the community of which said church is located.
3. Conduct weekly worship services, Sunday at 8:00 a.m. and 11:00 a.m.; Sunday School at 9:45 a.m.; Bible study classes are held every Monday night at 7:00 p.m. Midweek service is every Wednesday night at 7:30 p.m. The church will also hold annual one week anniversary services: Pastor's Anniversary - June; Church Anniversary - September; Choir Anniversary - October; Ushers Board Anniversary - May; Mission Anniversary - November.
4. Provide humanitarian support to the community and conduct a community outreach Home Mission Ministry.
5. Assist graduating high school seniors and other active church members in finding financial assistance to attend college or vocational school. Additionally, the church provides minimal financial assistance for books and supplies based on need and availability of funds.

6. Construct, build, repair and maintain buildings on property owned, located or controlled by the said corporation.

7. To borrow money and contract debts, issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidences of indebtedness payable at a specific time of event, whether secured by mortgage, pledge or otherwise, or secured for money borrowed or in payment for property purchased or acquired or any other lawful object or objects.

ARTICLE IV

The membership of this corporation shall constitute all persons hereinafter named as subscribers and members of the Board of Directors and all the members of Greater New Mount Carmel Missionary Baptist Church, in good and regular standing and such other persons as from time to time hereinafter may become members of the said church in the manner provided by the doctrines of the Baptist Church.

ARTICLE V

This corporation is to exist perpetually.
