ARTICLES OF INCORPORATION

OF

STANDING IN THE GAP, INC.  
(a Corporation Not For Profit)

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is

PURPOSES AND OBJECTIVES

The purposes and objectives for which the corporation is organized are:

To build, own, and operate, broadcast facilities as licensed by the FCC (Federal Communications Commission) for the purpose of religious programing, specifically that of the Christian Faith.

To create, promote and provide, educational programing, entertainment and music of a Christian nature to the general public.

ARTICLE III

CORPORATE POWERS

This corporation shall have all of the powers granted to corporations not for profit under the laws of the State of Florida as they now exist and as they may be increased by said laws in the future.

ARTICLE IV

MEMBERSHIP

This corporation shall consist of not less than three (3) members. To qualify for membership in this corporation, members must demonstrate a lifestyle in conformance to the Christian faith, and be willing to take an active part in forming the policies that govern to day to day operation of the corporation.

ARTICLE V

ADMISSION OF MEMBERS

Additional members may be admitted to this corporation upon a majority vote of existing members at any meeting called in accordance with the By-Laws of the corporation.

ARTICLE VI

TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VII

ARTICLE VIII

OFFICERS

The affairs of this corporation are to be managed by a Board of Trustees. From the Board of Trustees there shall be the following officers:

The officers shall be elected by a majority vote of the Board of Trustees at its first meeting and shall serve for terms of two (2) years each.

ARTICLE XI

BY-LAWS

This corporation shall have By-Laws which shall be made, altered or rescinded by majority vote of the Board of Trustees.

ARTICLE XII

AMENDMENTS TO THE ARTICLES OF INCORPORATION

Proposed amendments to the Articles of Incorporation shall be first approved by a majority of the Board of Trustees before being submitted to the membership. Passage of the proposed amendments will require a majority vote of the membership.

ARTICLE XIII

SPECIAL POWERS

The Board of Trustees may, by majority vote, establish one or more classes of membership other than general membership in this corporation. All classes of membership shall be non-voting members, with no rights to vote on the affairs of this corporation.

ARTICLE XIII

DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which are themselves exempt as organizations described in section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or the Federal, State, or Local government for exclusive public purpose.

ARTICLE XV

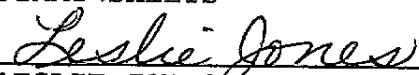
ACTIVITIES TO COMPLY WITH INTERNAL REVENUE CODE

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by:

(1) a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law or,

(2) a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue Law.

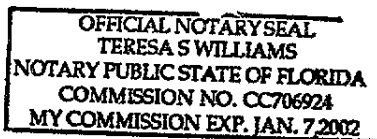
