



ARTICLES OF INCORPORATION

OF

O.P.R.D., INC.



The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is O.P.R.D., INC., (hereinafter, "Corporation).

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida mainly for the development of the second section of the Port de Paix.

ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office of this Corporation is 681 Northeast 125 Street, North Miami, Florida 33161 and the mailing address is the same.

ARTICLE 4 - INCORPORATOR

ARTICLE 6 - DIRECTORS

ARTICLE 7 - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE 8 - CAPITAL STOCK

This Corporation shall have no capital stock and shall be composed of members rather than shareholders.

ARTICLE 9 - QUALIFICATIONS OF MEMBERSHIP
