ARTICLE I. CORPORATE NAME

The name of this corporation is: PANACEA COVENANT CHURCH, INC. (A Florida Corporation, not for profit)

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is: 38 Otter Lake Road, Panacea, FL 32346.

ARTICLE III. PURPOSE

The purpose of this corporation is for its members to congregate as a church and to provide a place of worship and to encourage and facilitate the worship of God and disseminate the Gospel of Jesus Christ. To assist and help those in spiritual need.
