ARTICLES OF INCORPORATION OF

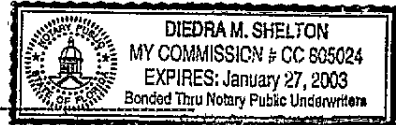
ARTICLE VI

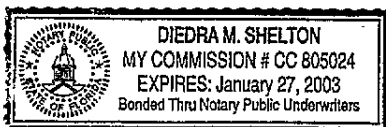
