## ARTICLES OF INCORPORATION OF RAMADAN-NASSAR MEDICAL FOUNDATION, INC.

- 1. Name. The name of the corporation shall be RAMADAN-NASSAR MEDICAL FOUNDATION, INC.
- 2. <u>Purpose</u>: This is a non-political, charitable corporation which is organized for the following purposes:
- (a) To establish and maintain one or more clinics and related services in Egypt to provide free or heavily-subsidized healthcare for needy Egyptians and to transport personnel and supplies to such locations for the purpose of providing such healthcare.
- (b) To provide financial assistance for healthcare of needy Egyptians in the United States.
- (c) To solicit and receive funds, gifts, endowments, donations, devises and bequests.
- 3. <u>Term of Existence</u>. This corporation shall commence on August 15, 2000 and shall have perpetual existence unless it shall be dissolved according to the laws of the State of Florida.
- 4. <u>Incorporator</u>. The name and address of the incorporator is as follows: A. MONEIM RAMADAN, 637 NW 13<sup>th</sup> Street, Gainesville, FL 32601.
- 5. <u>Directors</u>. The business affairs of the corporation shall be managed by the Board of Directors, which shall consist of not less than three nor more than nine persons. The term of office of the Directors and the manner of their election shall be stated in the bylaws.
- 6. <u>Location and Agent</u>. The street address in the State of Florida of the principal office, the mailing address and the initial registered office of the corporation is 637 NW 13<sup>th</sup> Street, Gainesville, FL 32601 and the name of its initial resident agent at such address is A. MONEIM RAMADAN.
- 7. <u>Limitation</u>. No part of the net earning of the corporation shall inure to the benefit of, or be distributable to, its members, Directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of

statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any further United States Internal Revenue law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law.)

8. Distribution of Assets Upon Dissolution. No person, firm or corporation shall ever receive any dividend or share in the income from the undertaking of this corporation and upon dissolution of this corporation all assets remaining after payment of the costs and expenses of such dissolution shall be distributed among one or more charitable organizations which are qualified for exemption under Section 501(c)(3) and Section 170(c) of the Internal Revenue Code of 1986, for a public purpose, and none of the assets shall be distributed to any member, officer or director of this corporation.

The undersigned, being the original incorporator hereinbefore named, for the purposes of forming a nonprofit corporation under Chapter 617 of the Florida Statutes, hereby makes, subscribes, acknowledges and files these Articles, hereby declaring and certifying that the facts herein stated are true, and accordingly, have hereunto subscribed his name this 15th day of August, 2000. The undersigned is familiar with and accepts the duties and obligations as registered agent for said corporation.
