ARTICLES OF INCORPORATION OF RENEWAL MINISTRIES, INC.

Article I

The name of the corporation shall be:

RENEWAL MINISTRIES, INC.

Article II.

The principal place of business and mailing address of this corporation shall be: 17826 Sunrise Dr., Lutz, FL 33549

Article III

The specific purposes(s) for which the corporation is organized are:

- To establish a Biblical Christian Church to provide and maintain a place of (a) worship of JEHOVAH, the Almighty God, our Heavenly Father, and the Lord Jesus Christ, His only begotten Son, through the Holy Spirit, and the promotion of Christian fellowship, edification, virtues, knowledge and spiritual gifts.
- To license and ordain Christian workers, ministers, teachers, and missionaries to (b) plan and establish branches and indigenous churches and out-reach missions.

- To publish, distribute nd teach Christian written and electronic media material to (g) the members of this corporation and the general public.
