Article 1: The name of the corporation is: Multi-Community Environmental Storm Observator 4 Inc.

Article 2: The Principal place of business is: 3716 Gaviota Drive Ruskin, Florida 33571

Article 3: This organization is organized exclusively for Charitable, Educational, or Scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code

Section 1 Not Withstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501 (c) (3) of the internal Revenue Code of 1986 or the corresponding provisions of future United States Internal Revenue Law.
