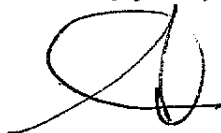

ARTICLES OF INCORPORATION

OF

A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned person, acting as incorporator of a corporation not-for-profit under the Florida Not for Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of this corporation shall be:

SUCCESS @ LIFE, INC.

ARTICLE II

Principal Office

The street address of the initial principal office of the corporation shall be 5501 - 31<sup>st</sup> Street South, St. Petersburg, Florida 33712.

ARTICLE III.

Purpose

The specific purpose for which this corporation is organized is to conduct a christian education ministry, to include but not to be limited to, Sunday School, bible study, and christian education for children, young adults and adults.

ARTICLE IV  
Term of Existence

This corporation shall have perpetual existence.

ARTICLE V  
Name and Address of Incorporator

ARTICLE VI  
Manner of Election of Directors

The manner in which the Directors are elected or appointed shall be established and stated in the By-Laws.

ARTICLE VII  
Amendments to Articles of Incorporation

The Articles of Incorporation may be amended, altered, changed or repealed in the manner now or hereafter prescribed by the Statutes of the State of Florida, and in accordance with the Bylaws of the Church, and all rights conferred upon officers, directors and members herein granted are subject to this reservation.

ARTICLE VIII  
General Provisions

This Corporation shall have all the powers and rights conferred upon it by Statute, including but not limited to, the following: to receive, take, hold, lease, buy, sell, mortgage and convey real

estate and personal property; to enter into, make and perform contracts of every kind; and to make, accept, endorse, and issue promissory notes, and other negotiable or transferable instruments and evidences of indebtedness, whether secured by mortgage or otherwise, and as permitted by the Bylaws of the Corporation..

ARTICLE IX  
Registered Agent and Registered Office

The initial registered agent and registered office of the corporation shall be as follows:

ARTICLE X  
Property Dedicated to Religious Purposes

The property of this Corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this Corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual. The Corporation is being formed to operate exclusively for religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax exempt organizations under that Code.

ARTICLE XI  
In Event of Dissolution

In the event of the dissolution of this corporation, all of its assets of every kind and character,

after the payment of its debts, if any, shall become the property of a church qualified under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent Federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax exempt organizations under that Code.
