ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PLAYWRIGHTS ROUND TABLE

To: Department of State Tallahassee, Florida

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned no for profit corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation is PLAYWRIGHTS' ROUND TABLE, INC..
- The following amendments to the articles have been adopted in compliance with the requirements of the provisions of the articles of incorporation:

The provisions of Paragraph (b) of Article IV are hereby DELETED and the following language SUBSTITUTED therefore:

> This corporation is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

> Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

3. Under the provisions of Article XVI of the Articles, members are not entitled to vote on amendments to the Articles. As required by the said Article, the within amendment was adopted by the affirmative vote of not less than two-thirds of the entire board of directors at a meeting held on November 27, 2001.
