ARTICLES OF INCORPORATION OF WILKINS' GROUP HOME OF BARTOW, INC.

The undersigned, being desirous of forming a corporation for charitable purposes, under the provisions of Chapter 617 of the Florida Statutes, does agree to the following:

ARTICLE I- Name

The name of this corporation is WILKINS' GROUP HOME OF BARTOW, INC.

ARTICLE II- Principal Office and Mailing Address of the Corporation

The address of the principal office of the corporation and its mailing address is 455 Restwood Avenue, Bartow, Florida, 33830.

ARTICLE III- Purpose

The general nature of the objections and purposes of this non-profit corporation are charitable and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code and shall be to more specifically:

- (a) To offer long term care for handicapped children without parents, or whose parents are unable to care for them.
- (b) To provide a home in which the handicapped children can be helped through care and training in a home-like atmosphere.
