ARTICLES OF INCORPORATION
OF
BEULAH LAND TEMPLE OF GOD CHURCH, INCORPORATED

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be Beulah Land Temple of God Church, Incorporated.

The principal place of this corporation shall be 1501 East Cross Street, P.O. Box 2950, Pensacola, Florida 32503.

ARTICLE II

The period of the duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

ARTICLE III

The purposes for which the corporation is organized are to preach the Gospel of Jesus Christ; to win lost souls to the Lord Jesus Christ; to pray for persons to be healed; to counsel pre and post marital couples concerning duties, responsibilities and commitment required in Christian Biblical marriage; to counsel single youth in accordance with Biblical principles to live pure and holy lives, obedient to God's plan for their lives; and to perform all lawful acts normally considered pertinent to a church ministry.

ARTICLE IV

The qualifications for members and the manner of their admission are that all who confess Jesus Christ as Lord and Savior, repent of past sins, and seek to follow Jesus Christ may be members. The manner of one's admission as a member of this church ministry shall be provided for in the bylaws.

ARTICLE V

ARTICLE VI

This corporation is organized under a non-stock basis. This corporation will seek and claim to be exempt from federal tax obligation of non profit corporations because of its religious activity of the kind described in Section 501(c)(3) and Section 501(d) Internal Revenue Code.

ARTICLE VI

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3), 509(a)(i), 170(b)(i)(A)(i) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local Government for exclusive public purpose.
