(a Florida Not For Profit Corporation)

The undersigned, as authorized representative of The Mission Anglican Church, Inc., a not for profit corporation under the Florida Not for Profit Corporation Act, submits the following First Amended and Restated Articles of Incorporation for the corporation:

Article I - Name

The name of the corporation is The Mission Anglican Church, Inc.

Article II - Principal Office

The principal address for the corporation is 609 North Alzaniz Street, Pensacola, Florida 32501 and the mailing address for the corporation is 319 East Jackson Street, Pensacola, Florida 32501.

Article III - Purpose

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes under § 501(c)(3) of the Internal Revenue Code of 1986, as amended. More specifically, the corporation is organized for the religious purposes and to be and function as a Christian church.

Article IV – Manner of Election

The manner in which members of the vestry are elected or appointed shall be as stated in the corporation's bylaws.

There are no members or members entitled to vote on these First Amended and Restated Articles of Incorporation. These First Amended and Restated Articles of Incorporation were adopted by the Vestry members on May 20, 2020.


