**ARTICLES OF INCORPORATION
OF

Article I

The legal name of this corporation shall be: **The Humane Society of Levy County, Inc.**
This corporation is a not for profit corporation in the State of Florida.

Article II

The principal place of business and mailing address of the corporation shall be: 319
Shearer St. Inglis, FL 34449

Article III

The corporation is established to promote and encourage the survival of all animals. To lower the rate of euthanasia and find proper adoptive homes for all domestic animals, and to work with wildlife rescue organizations in their efforts to protect them from becoming endangered or mistreated. The corporation will strive to provide adequate shelter for said animals including proper nutrition, medical care and whatever needs it deems is proper to secure a healthy, happy home for the domestic animals placed in their care.

The corporation may also sponsor fund raising and public education programs, administer property, when necessary, and undertake to provide such other services and programs as may be incidental to or reasonably necessary to further the goals expressed herein.

Article IV

The Corporation, shall have a CEO (Chief Executive Officer)a secretary/treasurer at incorporation, with a board of directors added by amendment at a later date. The initial incorporators (2) terms of office will be perpetual. The manner of elections will stated in the bylaws.
