## ARTICLES OF INCORPORATION OF COVENANT COMMULTY FELLOWSHIP, INC.

ONE:

The Name and address of this principal corporation is Covenant Community Fellowship, Inc., 8641 NW 52nd Street, Lauderhill, Florida 33351. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.

TWO:

This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes to establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic and Social Development Programs, but shall not be limited to: Homeless, Health Care, Child Care, Youth at High Risk, Tutorial, Land Acquisition, Housing, Job Training, Job Placement, Counseling, Employment, Marriage Ceremonies, Burial and Singles Activities Center, Youth Conferences, Crusades, Revivals, Seminars, Drama (The Arts), Radio, Television, Tape, Video and Book Distribution, other programs to aid those in need and activities to uplift and build the body of Christ.

THREE:

The duration of this corporation shall be perpetual, no stock and shall have no members.

FOUR:
