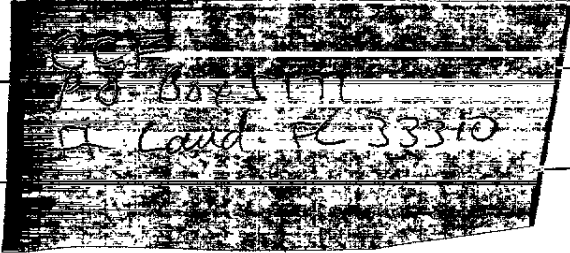

**ONE:** The Name and address of this principal corporation is Covenant Community Fellowship, Inc., 8641 NW 52nd Street, Lauderhill, Florida 33351. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.

**TWO:** This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes to establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic and Social Development Programs, but shall not be limited to: Homeless, Health Care, Child Care, Youth at High Risk, Tutorial, Land Acquisition, Housing, Job Training, Job Placement, Counseling, Employment, Marriage Ceremonies, Burial Services, Youth and Singles Activities Center, Bookstore, Conferences, Crusades, Revivals, Seminars, Drama (The Arts), Radio, Television, Tape, Video and Book Distribution, other programs to aid those in need and activities to uplift and build the body of Christ.

**THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.

**FOUR:** The address of the REGISTERED office is 8641 NW 52nd Street, Lauderhill, Florida 33351, and the name of the registered agent of the corporation shall be:

- (a) This corporation is organized and operated exclusively for Religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

**SIX:**




