## **ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act hereby adopt(s) the following Articles of Incorporation.

### **ARTICLE I:**

#### **NAME: PRINCIPLE PLACE OF BUSINESS**

**Success – Health Ministries Inc.**

**The principle place of business and mailing address of this corporation shall be:**

### **ARTICLE II:**

#### **BUSINESS AND PURPOSE**

**The nature of this corporation is to provide comprehensive programs and support services to facilitate personal growth and leadership development; health education, training and disease prevention; self-discovery and career advancement; business and economic development; community, family and individual empowerment; and supplement academic education for children, youth and adults, all to address and meet the unmet needs of the under-served wherever they exist**

**Generally, to carry out any act that is not inconsistent with the corporation laws of the State of Florida or any other laws, and any act which the Board of Directors may determine from time to time to do what is in accord with the purpose of the non-profit corporation.**

**To engage in any lawful purpose not for pecuniary gain or prohibited by Florida law, and to have and exercise all the rights and powers conferred on nonprofit corporations under Florida law as such is now in effect or may at any time hereafter be amended.**

**Notwithstanding any other provision of these articles, this corporation will not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of future United States Internal Revenue laws.**

### **ARTICLE III: DISSOLUTION**

**In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in section 501 (c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or the Federal, State or local government of exclusive public purpose.**

**ARTICLE IV:**

**MANNER OF ELECTION OF DIRECTORS:**

The manner in which the directors are elected or appointed is: The directors, being no less than three, will be appointed by the Incorporator and initial Board until duly elected in accordance with the By-laws.

**ARTICLE V:**

**EXISTENCE OF THE CORPORATION**

The corporation shall have perpetual existence.
