In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

THE ROGER R. MOBLEY, JR., EDUCATION FOUNDATION INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

TO PROVIDE, AT A MINIMUM, TWO (2) EDUCATION SCHOLARSHIPS PER YEAR TO THE TOP BLACK MALE AND FEMALE BASKETBALL PLAYER WITH THE HIGHEST GRADE POINT AVERAGE (G.P.A.) IN AN AMOUNT RANGING FROM \$500 to \$2,500 ACCORDING TO THE FUNDS AVAILABILITY WITHIN THE FOUNDATION. THE AMOUNT, AS WELL AS THE NUMBER OF (cont.)

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

THE DIRECTORS OF THE FOUNDATION WERE ELECTED BASED ON A UNANIMOUS DECISION BETWEEN FAMILY AND FRIENDS AFTER THE DEATH OF ROGER R. MOBLEY, JR. ALL PARTIES INVOLVED WERE VOTED TO REPRESENT THE ORGANIZATION BASED UPON THEIR EXPERTISE AND RELATIONSHIP WITH THE DECEASED AFTER A VOTE BY ALL MEMBERS DIRECTLY AND INDIRECTLY INVOLVED.





ARTICLES OF INCORPORATION (Cont.)

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE III PURPOSE (cont.):

SCHOLARSHIPS AND TYPE WILL BE ADJUSTED ACCORDINGLY, BASED ON THE FOUNDATION'S ASSETS. THE SCHOLARSHIP FUND IS EXCLUSIVELY FOR STUDENTS FROM BOYD ANDERSON HIGH SCHOOL, LOCATED AT 3050 NW 41st STREET, LAUDERDALE LAKES, FL 33309. OF WHICH THE DECEASED WAS IN ATTENDANCE PRIOR TO HIS DEATH. THE FOUNDATION RESERVES THE RIGHT TO OFFER THE SCHOLARSHIP ONLY TO BASKETBALL PLAYERS UNTIL FURTHER CHANGES ARE MADE, IN HONOR OF THE DECEASED WHO WAS ALSO A BASKETBALL PLAYER AT BOYD ANDERSON HIGH. THE FOUNDATION FURTHER RESERVES THE RIGHT TO OFFER SUCH FUND TO OTHER CATEGORY OF STUDENTS WITHIN THE SCHOOL, WITH FIRST PRIORITY GOING SPECIFICALLY TO THE ORIGINAL CATEGORY LISTED WHO ARE GRADUATING THAT YEAR. THE FOUNDATION ALSO RESERVES THE RIGHT TO STIPULATE HOW THE MONEY WILL BE USED TOWARDS FURTHERING THE EDUCATION OF THE RECEIPIENTS. ANY AND ALL ADDITIONAL CHANGES TO THE FOUNDATION'S PURPOSE AND FUNCTION WILL BE DULY NOTED IN THE MINUTES OF THE RESPECTIVE MEETING AND AMMENDED WITH THE FLORIDA DIVISION OF CORPORATION IN ACCORDANCE WITH APPLICABLE LAWS AND PROCEDURES.
