ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The specific purpose(s) for which the corporation is organized is(are): a) To unify Black Law Enforcement Officers at the executive and command levels. b) To conduct research in relevant areas of law enforcement. c) To evaluate and recommend legislation relating to the criminal justice process. d) To establish effective means and strategies for dealing with racism in criminal justice. e) To develop communication techniques for sensitizing the criminal justice system to the problems of the black community.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

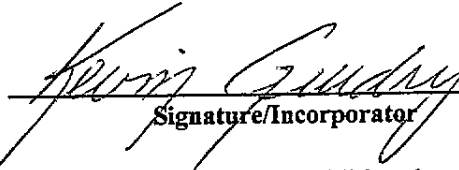

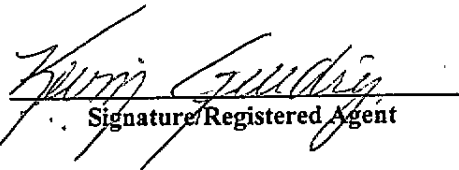
