following Articles Of Corporation:

ARTICLE I - NAME

The name of this Corporation shall be. ZOSCHNICK GROUP HOME, INC.

ARTICLE II - TERM

This Corporation shall have perpetual existence unless dissolved sooner by operation of Law.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business for the Corporation shall be:

ARTICLE IV - PURPOSES

<u>Section 1</u>.
