ARTICLE I

Name

The name of this corporation is L.I.F.E. HOMES, INC. and is organized in compliance with Chapter 617, Florida Statutes, as amended.

ARTICLE II

Principal Office

The initial principal office of the corporation is:

Casselberry, Florida 32707

ARTICLE III

Duration

The term of existence of this corporation is perpetual. The corporate existence will commence on the filing of these Articles of Incorporation with the Department of State and shall continue until terminated pursuant to the By-Laws.

ARTICLE IV

Purpose

The purpose for which the corporation is organized is:

To provide a housing environment for individuals with mental illnesses and/or challenges in which each individual may reach his/her potential level of independence and achieve a productive role within their respective community, to provide quality group home and supportive individual living assistance and to guide these individuals in locating additional community resources in order to optimize their education, employment, transportation and socialization options.

Corporation is also entitled to conduct any and all business matters as set forth in *Chapter 617, Florida Statutes*, as amended from time to time.

ARTICLE V

Directors

The corporation shall have four (4) members of the initial Board of Directors of the corporation, who will serve until the first election of Directors. In no event, however, shall there be less than three (3) members of the Board of Directors of the corporation. The directors shall be elected pursuant to the By-Laws of the corporation.
