ARTICLE I

The name of this Corporation is **ELDER SERVICES NETWORK OF FLORIDA, INC.**

ARTICLE II

The address of the place of business of the Corporation is Post Office Box 547357, Orlando, Florida 32854-7357. The address of the initial registered office maintained pursuant to Section 617 F.S. is 225 East Robinson Street - Suite 600, Orlando, Florida 32802 and the name of the Corporation's initial registered agent to receive service of process is Susan Neiswender Black.

ARTICLE III

The Corporation is organized and operated exclusively for the charitable and educational purposes of promoting the general health and welfare of the of the elder community through developing, organizing, managing and operating a network of services which provide household and domestic care, and other necessary services on a fee-for-service basis which enables these necessary services to be available to low-income senior citizens and otherwise needy sectors of the community. While pursuing its purposes, the Corporation may exercise the powers granted now or in the future by Chapter 617, Florida Statutes, and by common law.
