ARTICLE I NAME

The name of this corporation shall be **In-Touch Evangelistic Outreach Ministries, Inc.**

ARTICLE II PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose of In-Touch Evangelistic Outreach Ministries, Inc. is to meet the need of communities everywhere, regardless of race, creed, or religion. This will be done through innovative activities with focuses on education, motivation, self-esteem, and spiritual awareness. We will uphold and build upon the foundation that Jesus Christ has laid. In-Touch Evangelistic Outreach Ministries, Inc. is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations under Section 501 (c) (3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code.)

ARTICLE IV MISSION

In-Touch Evangelistic Outreach Ministries, Inc. is a community based organization whose mission is to touch lives through youth support groups, elderly support groups, feeding programs, foreign missions, prison rehabilitation groups, workshops, lectures, conferences, retreats, revivals, and crusades.

ARTICLE V MANNER OF ELECTION

The directors/officers of In-Touch Evangelistic Outreach Ministries, Inc. will be by appointment, by President, Evangelist Muriel Avant-Fuqua.

No manner of the net earnings of the corporation/organization shall inure to the benefit of, or distributable to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c) (3) purposes. No substantial part of the activities of the corporation/organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distributions of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal Income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any further Federal tax code) or (b) by a corporation/organization, contributions to which are deductible under Section 170 (2) of the Internal Revenue Code (for corresponding section of any future Federal tax code.)

We believe that the redemptive work of Christ on the cross provides healing for the human body in answer to believing in prayer.

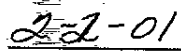
We believe that the baptism in the Holy Ghost according to Acts 2:4 is given to believers who ask for it.

We believe in the sanctifying power of the Holy Spirit by whose indwelling, the Christian is enabled to live a holy and separated life in this present world. Amen.

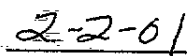
