ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF THE LAKEWOOD RANCH/EAST COMMUNITIES CHARITABLE FUND, INC. SECRETARY OF STATE

Pursuant to Section 617.1006, Florida Statutes, the Corporation desires to amend its Afticles of Incorporation having been filed with the Florida Department of State on September 16, 2002, under Document Number No2000151568.

A Florida Not For Profit Corporation

- 1. The name of this Corporation is THE LAKEWOOD RANCH/EAST COMMUNITIES CHARITABLE FUND, INC.
- 2. The Articles of Incorporation are amended to delete the existing Article I in its entirety and insert a new Article I which shall read as follows:

The name of this Corporation shall be THE LAKEWOOD RANCH COMMUNITY FUND, INC., and its principal office will be at 6215 Lorraine Road, Bradenton, Florida 34202.

3. There are no members entitled to vote on the amendment. Pursuant to Section 617.1002(1)(b), Florida Statutes, the foregoing amendment was adopted by a majority vote of the Board of Directors then in office at a meeting held October 11, 2004, and the number cast in favor of the Amendment was sufficient for passage.
