ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of the Corporation is LUTZ CHAMBER OF COMMERCE, INC. The principal place of business is 19134 Cherry Rose Circle, Lutz, Florida 33549; the mailing address shall be: 19134 Cherry Rose Circle, Lutz, Florida 33549.

ARTICLE II. DURATION

This Corporation shall have perpetual existence, commencing upon filing of these Articles.

ARTICLE III. PURPOSE

The general nature of the business to be transacted by the Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is the method as stated in the bylaws.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

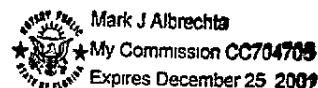
