Articles of Incorporation of Florida Nonprofit Corporation

ARTICLE I - NAME

The name of the corporation shall be The Time Has Come Ministry, Inc., and whose address is 18332 SW 135 Avenue Miami, Fl. 33177

ARTICLE II - PURPOSE

This is a nonprofit corporation, organized solely for general charitable purposes to the Florida Corporation not for profit law set forth in Section 617 of the Florida Statues.
