ARTICLES OF INCORPORATION
OF

The undersigned, acting hereby as Incorporator for the purpose of becoming a not-for-profit corporation under the laws of the State of Florida, by and under the provisions of the status of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation not-for-profit, pursuant to Chapter 617, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **CRYSTAL STAIRS CENTER, INC.**

ARTICLE II

Duration

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to provide various training programs, support and assistance for abused and disadvantaged women and their families, and to engage in any lawful purpose or purposes not for pecuniary profit.

ARTICLE IV

There shall be two members of the initial board of directors of the corporation. The names and addresses of the persons who are to serve as directors until the first election thereof are as

follows:

The corporation shall have three members. The members, from time to time, are prescribed in the bylaws.

ARTICLE IX

In the event that the corporation is dissolved, any assets remaining in the corporation after liquidation shall be equally distributed among the shelters for abused women located in St. Johns County, Florida.

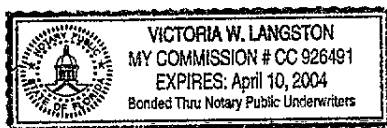

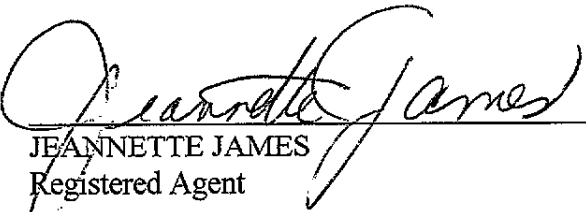
