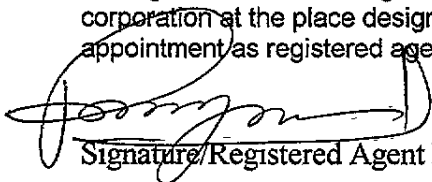

### **By laws and policies**

(1) The corporation may from time to time add more members as and when it is needed. The Any one who supports the mission can become a member after filing appropriate application form. Upon dissolution of the corporation the assetss will be distributed to the any non-for profit organization under 501 C (1) established in the State of Florida according to the wishes of the incorporators or their designees.

(2) The corporate officers may be employed by the organization as and when needed. The president will also function as the executive officer of the corporation. Professional services offered by the incorporators shall be compensated according to the industry standards. (3) The corporation shall remain as a non-partisan entity adhere to the federal policies of non discrimination.

(4) The corporation will not discriminate and one on the basis of race, age, gender, disability, religion, national origin or sexual preferences.

(5) Employment with the corporation I voluntary and can be ended at the will of either party with reasonable (30 days) notice.
