ARTICLES OF INCORPORATION

The undersigned Incorporators to these Articles of Incorporation, being natural persons, competent to contract, do hereby form a Corporation not for profit under the laws of the State of Florida.

ARTICLE I - NAME. The name of this Corporation is KEYSTONE COMMUNITY LUTHERAN CHURCH, INC.

ARTICLE II - PRINCIPAL OFFICE. The principal place of business and mailing address of this Corporation shall be 3331 Masters Drive, Clearwater, Florida 33761.
