ARTICLES OF INCORPORATION OF

NEW MOUNT PLEASANT MISSIONARY BAPTIST CHURCH INC.

We, the undersigned, hereby associate ourselves for the purpose of becoming a non-profit religious corporation under the Laws of the State of Florida, by and under the provisions of the Statues of the State of Florida providing for the formation, Liability, Rights, Privileges, Immunities of a corporation not for profit.

Article I

Name of Corporation

The name of the corporation is:

NEW MOUNT PLEASANT MISSIONARY BAPTIST CHURCH INC.

Article II

Purpose

The purpose for which the organization is organized is exclusive religious, charitable, scientific, literary, and educational, within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 of corresponding provisions of any future United States Internal Revenue Law.

To acquire, buy, hold, own, self, exchange convey, Lease, or otherwise dispose of goods, chattels, effects and Merchandise.

To Mortgage, Lease, Hypothecate, Convey Exchange, and dispose of Lands and Chattels to acquire, by gifts, annuity, Bequest, of otherwise, Property. Both real, and personal or otherwise, and to promote the diffusion of religious Literature and Education Loyal to the New Testament Faith as held by the church.

Articles III

Qualification of Members

Persons who believe in Repentance toward God, and Faith in the Lord Jesus Christ as their Lord and Savior, and who are willing to confess Him publicly as Lord, and follow Him in Baptism and to observe the Ordinances of Christ and to be governed by his Laws and the Church, are qualified and eligible for membership in this Church Corporation.

The Manner of admission to membership shall be by acceptance of this church from other churches of like faith; and other faiths by being baptized in this Church and the Profession of Faith as herein before provided upon a favorable majority vote of the membership of the said Church Corporation present at any Meeting of the Church.

Article IV

By-Laws

By-Laws of the Church Corporation are to be made, offered, and rescinded by a majority of the qualified members of the Church, present and voting at a regular or special business meeting.

Article V

Corporate Existence

This Corporate shall have perpetual existence unless sooner dissolved by the Laws of the State of Florida.

Article VI

Officers

The affairs of the Church Corporation shall be managed by a Pastor, Officers, Financial Secretary, Treasurer, and a Board of Trustees as authorized by the Church. Article XIII

Prohibited Activities

Not withstanding any other provision of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on by (a) a Corporation exempt from Federal Income tax under section 501 (c) (3) of the Internal Revenue code of 1954 or the corresponding provision of any rule of any future United States Internal Revenue Law or (b) a Corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code 1954 or any other corresponding provisions of any future United States Internal Revenue Law.
