

- ONE:** The name and address of this principal corporation is Light of the Word, Inc., 283 Sandy Run, Melbourne, FL 32940. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO:** This corporation is non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Religious Benefit Corporation Law for, religious, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of Economic Development Programs, but, shall not be limited to: Homeless, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.




