THE UNDERSIGNED ACTING AS INCORPORATOR(S) OF A CORPORATION PURSUANT TO CHAPTER 617, FLORIDA STATUTES, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION: PURSUANT TO SECTION 617.0202, FLORIDA STATUTES, THE ARTICLES OF INCORPORATION SET FORTH THE FOLLOWING:

ARTICLE I:
