

FOR

The undersigned subscriber to these Articles of Incorporation a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - DISPOSITION OF ASSETS ON DISSOLUTION

If this corporation has to be dissolved for any reason, all its assets shall be transferred to one of the affiliated not for profit organizations located within the City of Orlando, Florida.

ARTICLE IV - PURPOSE



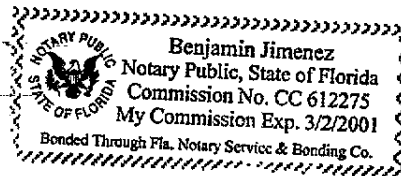
