#### ARTICLES of INCORPORATION

of

#### BRIDGE OVER TROUBLED WATERS, INC. (A Non-Profit Corporation)

The undersigned incorporator, for the purpose of forming a Non-Profit Corporation under the Non-Profit Corporation Act, Chapter 617, Florida Statues (1999), as amended, do hereby certify:

#### ARTICLE ONE Name

The name of the Corporation shall be BRIDGE OVER TROUBLED WATERS, INC.

### ARTICLE TWO Principal Office and Address

The place in this state where the principal office of the Corporation is to be located is C/O Wesley Ogburia, 115 East Granada Boulevard, Suite 1, Ormond Beach, Florida 32176, and the mailing address shall be the same.

#### ARTICLE THREE Duration

The term of existence of the Corporation shall be perpetual; and the corporate existence will commence on the filing of these articles by the Department of State Florida.

### ARTICLE FOUR Purpose

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Florida upon not-for-profit corporations, including, but without limitation thereon, to solicit funds from its members, or from members of the community at large, to organize fund-raising activities among its members, to receive gifts, devises, bequests and contributions in any form, holding and investing the receipts, and to use or apply the income therefrom or distribute the same for the above purposes.

### ARTICLE FIVE Earnings and Activities of the Corporation

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Articles Four hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided by section 501 (h) of the Code), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of or opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

#### ARTICLE SIX Directors

The affairs of this Corporation shall be conducted by a board as set forth in the bylaws of this Corporation. The method of election of the directors of this Corporation is set forth in the bylaws. The names and street address of the initial directors are as follow:

#### ARTICLE SEVEN Dissolution

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the Corporation is then located, exclusively for the such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

## ARTICLE EIGHT Registered Office and Agent

The initial registered office of the Corporation shall be located at 137 Robinhood Drive, Deland, Florida 32724. The initial registered agent of the Corporation at that address shall be Bonnie S. Black.
