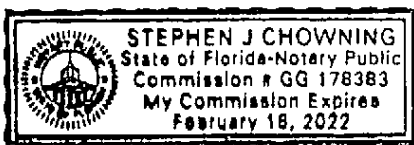

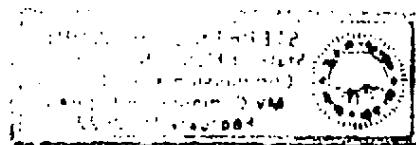

Amendment No. 1: Article 8, Section 8.1 of the Articles of Incorporation of Paradise Lakes RV Park Condominium Association, Inc., is amended to read as follows:

8.1 The affairs of the Association shall be managed by a Board of Directors who ~~need not~~must be members of the Association. ~~The membership of the Board shall consist of not less than three (3) Directors until the control of the Association is transferred to the Unit Owners other than the Developer pursuant to Florida Statute 718.301.
