ARTICLES OF INCORPORATION
OF

A NON-PROFIT ORGANIZATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 817 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be BADCAT WRESTLING CLUB, INC.

The address of the principal office of this corporation shall be 2868 Meadow Wood Drive, Clearwater, Florida, 33761, and the mailing address of the corporation shall be the same.

ARTICLE II.

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for this purpose, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code. In furtherance of this general purpose, the corporation shall exclusively foster national and/or international amateur competition in the sport of wrestling. It shall primarily conduct national and/or international amateur wrestling competitions an/or support and develop amateur athletes for such competition. Subject to the limitations set forth above, the corporation shall possess the authority and powers conferred by the laws of the State of Florida.

ARTICLE III.

The Directors of the corporation are as follows:

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code.

ARTICLE IX.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

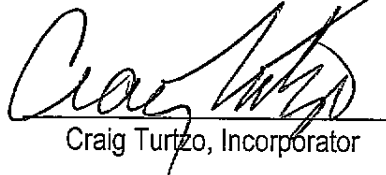
