The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation

I.

THE NAME OF THE CORPORATION IS ***ETC...ETERA YOUTH MINISTRIES INCORPORATED.***

II.

THE PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS OF THIS CORPORATION SHALL BE: ***102 #C, EAST BROWNLEE STREET, STARKE, FLORIDA 32091 (Place Of Business). THE MAILING ADDRESS IS RT 6 BOX 1529 STARKE, FLORIDA 32091 THE CORPORATION IS ORGANIZED PURSUANT TO THE PROVISIONS OF THE FLORIDA NON-PROFIT CORPORATION CODE.***

III.

THE CORPORATION SHALL BE ORGANIZED AND OPERATED EXCLUSIVELY FOR RELIGIOUS PURPOSE WITHIN THE MEANING OF SECTION 501 C (3) OF THE INTERNAL REVENUE CODE OF 1998, OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW, THAT DOES NOT DIRECTLY CONFLICT WITH OUR BELIEFS AND DOCTRINE, AS SET FORTH IN THE KING JAMES VERSION OF THE HOLY BIBLE. THE CORPORATION SHALL PROVIDE MATERIAL AND TRAINING FOR THE ONGOING ACADEMIC AND SPIRITUAL AWARENESS OF THE APPROXIMATE PERCENTAGE OF YOUTH THAT ARE THE AVERAGE AGE OF 17 YEARS OR YOUNGER.

ETC...ETERA YOUTH MINISTRY, IS NOT ORGANIZED, NOR SHALL IT OPERATE FOR PECUNIARY GAIN OR PROFIT, AND DOES NOT CONTEMPLATE THE DISTRIBUTION OF GAINS, PROFITS, OR DIVIDENDS TO ITS MEMBERS AND IS ORGANIZED SOLEY FOR NON-PROFIT PURPOSES. THE PROPERTY, ASSETS, AND NET INCOME OF THIS COOPERATION IS DEDICATED TO CHARITABLE, EDUCATIONAL, CULTURAL RECREATIONAL AND/OR SOCIAL BENEFITS TO MINORS: AND/OR RELIGIOUS PURPOSES, AND NO PART OF THE PROFITS OR NET INCOME OF THIS COOPERATION SHALL EVER INSURE TO THE BENEFIT OF ANY PROFIT SHAREHOLDER OR INDIVIDUAL, ON THE DISSOLUTION OR WINDING UP OF ETC...ETERA YOUTH MINISTRY. THE ASSETS REMAINING AFTER PAYMENT OF ALL DEBTS AND LIABILITIES OF THIS CORPORATION SHALL BE DISTRUBUTED AS ASSIGNED BY THE THEN CURRENT BOARD OF DIRECTORS. THE CORPORATION SHALL HAVE PERPETUAL DURATION.

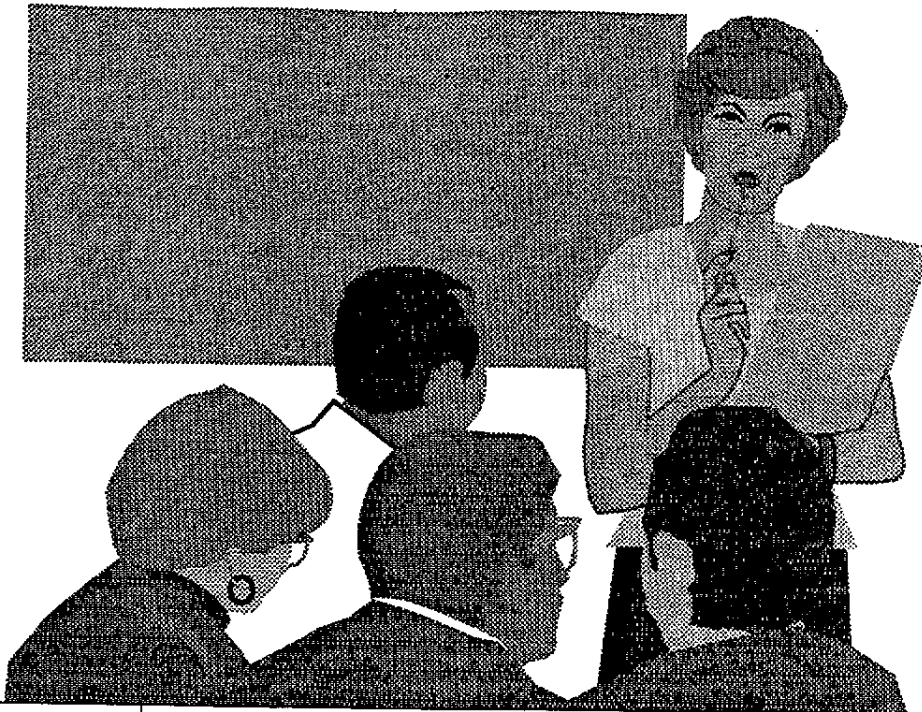

ETC...ETERA Youth Ministry, Inc. Will provide the following services to the Youth in the community and abroad:

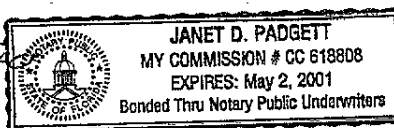
The Corporation will ascertain that the following academic support/self study materials is available to the approximate percentage of individuals 17 years of age and younger:

3. Youth Referral System (General) Guidance Counseling.
4. Personal Development (Adult Mentoring), on the subject of life skills, etc...
5. Provide Clothing and basic household items, at minimum cost, to needy families with children of the percentage of individual family members 17 years of age or younger. (In accordance with at-large donations provided to The Bradford Outreach Thrift & Donation Center) who's Owner has agreed to provide sponsor ship for an indefinite period of time.
