WHEREAS, it is deemed to be desirable and in the best interest of this Corporation and its shareholders that it be incorporated pursuant to the Florida Non-Profit Corporation Act, Chapter 617; now, therefore, be it:

RESOLVED, that certified copy of the original Articles of Incorporation for such corporation be attached hereto and that the following Articles of Incorporation for such corporation be hereby adopted as follows:

The undersigned, acting as incorporators of a Florida corporation under the Florida Non-Profit corporation Act, Chapter 617, adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

NAME. The name of this corporation is **NEW BEGINNING CHURCH OF DELIVERANCE, INC.**

ARTICLE II.

PRINCIPAL OFFICE. The principal place of business mailing address of this corporation shall be **2758 N.W. 50th Street, Miami, Florida 33142.**

ARTICLE III.

DURATION. The corporation shall have perpetual existence. The corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE IV.

PURPOSE. The corporation is organized in order to provide religious worship and instruction, churches, schools, missions, pastoriiums, and other institutions connected therewith of a religious, educational, charitable and benevolent character to the end that people may be generally instructed and guided concerning these articles of faith which are most surely held among Pentecostal Churches and to advance spiritual growth and enlightenment, moral and personal purity among people; to promote home and foreign missions; and to aid in the spread of the Gospel of JESUS CHRIST.
