Articles of incorporatinon

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation

Article I: Name

The name of the corporation shall be: Shared Grace of God Church and Ministry Inc.

Article II: Principal Office

The principal place of business and mailing address of this corporation shall be:

Article III: Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

Christian Church and Ministry with a primary focus on self-discovery, emotional and spiritual healing and growth. Will offer and act as a directory for support groups and 12-step programs. Our church is open to all. We are not here to recruit or challenge the faith or lack of faith of any individual or group. Our example shall be our witness to the world that others may choose to follow. Political discussion or propaganda is strictly prohibited. Any attempt to persuade members of this Church and Ministry towards any candidate, litigation or other politically related topic shall be silenced! The Church and Ministry must never be used as a vehicle for political gain or influence. No speaker shall be permitted to formally address the congregation if that speaker is in any way campaigning for himself or herself or for another person or topic. Political involvement on a personal level is encouraged but no guidance or influence towards or from the Church and Ministry shall be tolerated. We are not here to control the masses. We are here to free the individual.

Article IV: Manner of Election of Directors

The manner in which the directors are elected or appointed is:

1. Officers. The officers of the Church shall consist of the Senior Minister, then in the service of the Church. The Moderator, the Treasurer and the Clerk shall be appointed by the Church leaders adhering to strict guidelines as outlined in article III.
2. Church Council. The Church Council shall consist of Church Members chosen by Church officers.
3. Board of Trustees. The Board of Trustees shall consist of members of the Church chosen by ballot of the Members at the Annual Meeting. As Stated In the By-Laws.


