ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be the Gainesville Advertising Federation, Inc, hereafter referred to as the Federation, and shall be affiliated with the American Advertising Federation and the Fourth District of the American Advertising Federation.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business for the Gainesville Advertising Federation, Inc. shall be c/o Baird Center 619 S. Main Street, Suite K, Gainesville, Florida 32601. The mailing address shall be P.O. Box 142107 Gainesville, FL 32614.

ARTICLE III. PURPOSE

The purpose of the Federation shall be to strive for the betterment of advertising in all areas affecting the advancement and general welfare of the business and its service to the public; to assist and promote public service causes; to advance the standards of advertising through a voluntary program of self-regulation; to recognize excellence in advertising; to offer programs to promote fellowship, communication, career enhancement, and education among members of the advertising industry.

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The election of directors of the Federation shall be conducted according to the manner described in the Federation bylaws, Article 10, Sections 1-3.
