**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S., (Not for Profit)

**Article I      Name**

The name of the corporation shall be:

The Sanctuary of Shekinah Inc.

**Article II      Principal Office**

**Article III    Purpose**

The purpose for which the corporation is organized is:

- A. For the preaching of the Gospel of Jesus Christ. For the advancement of religion and any other related or corresponding educational and/or counseling and charitable purposes by the distribution of it's funds for such purposes.
- B. To extend and maintain a Church to preach the word of God for the saving of souls of men and to continue to promote the church as designed by the word of God. To buy, manage, own and hold real and personal property necessary and proper for a place of worship and to carry on related educational and charitable work under the rules and regulations of the by-laws of the Church, in harmony with these Articles of Incorporation and the laws of Florida.
- C. To be an independent religious entity not affiliated with any denominational body missionary organization or branch thereof.
- D. To operate exclusively in any other manner for such religious, charitable and educational purposes as will qualify it as an exempt organization under Section 501(c) (3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provision of any subsequent Federal tax Laws, covering the distribution to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.
- E. To operate as a corporation not for profit in accordance with the provisions of the laws of the State of Florida relating to corporations not for profit.

ARTICLE IV

Manner of election of directors:

The manner and the qualification for directors shall be provided in the laws of this corporation.

ARTICLE V

The Corporate powers of this corporation are as provided in section 617.0302, Florida Statutes unless limited are as follows:

The Corporate power of the Church shall be provided in the by laws of this corporation and in accordance with the provisions of the State of Florida relating to corporations not for profit.




