ARTICLES OF INCORPORATION

OF

OR OR WILL RURAL YOUTH SOCCER ASSOCIATION, INC.

A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt and following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be RURAL YOUTH SOCCER ASSOCIATION.

The principal address of the corporation at the time of incorporation is 204 Forest Park Avenue, Temple Terrace, Hillsborough County, Florida.

ARTICLE II. DURATION

The duration of this corporation is perpetual unless dissolved according to law.

Corporate existence shall commence at the date these articles of incorporation are filed by the Department of State.

ARTICLE III. PURPOSE

- (a) The specific and primary purpose for which this corporation is organized is to promote and encourage youth soccer; to promote and encourage education, exercise and recreation of it members; to promote sociability and friendship among its members; and to manage and conduct entertainments, excursions, and social meetings.
- (b) This corporation is formed and shall be operated exclusively for pleasure, recreation, and other nonprofit purposes. No part of any net earnings shall inure to the benefit of any member, trustee, or officer of the corporation except as provided by law.
- (c) This corporation shall have and exercise all powers conferred upon not for profit corporations under the laws of the State of Florida generally, and specifically as provided in Section 617.0302 of the Florida Not for Profit Corporation Act, provided, however, that this

corporation has no power to engage in any activity that in itself is not in furtherance of its purposes as set forth in subparagraphs (a) and (b) of this Article III.

ARTICLE IV. QUALIFICATION AND ADMISSION OF MEMBERS

The qualification for members and the manner of their admission by the corporation shall be as regulated by the corporation's bylaws.

ARTICLE V. REGISTERED OFFICE AND REGISTERED AGENT

The street address of the corporation's initial registered office is 204 Forest Park Avenue, Temple Terrace, County of Hillsborough, Florida, and the name of the corporation's initial registered agent at such address is ALAYNE GAIL UNTERBERGER.
