ARTICLES OF INCORPORATION OF

A NOT FOR PROFIT CORPORATION

We the undersigned, do hereby join together in the formation of a non profit corporation, following the terms and conditions, to wit:

ARTICLE I

This corporation will be entitled 'Fresh Start Insight Services, Inc.'

ARTICLE II

ARTICLE V

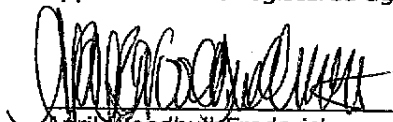
