ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I. NAME The name of the Corporation is Faith Covenant Academy, Inc.

ARTICLE II. DURATION The duration of the Corporation is perpetual.

ARTICLE III. PRINCIPAL OFFICE The principal place of business and mailing address of this corporation is 820 S. Bridgestone Ave., Jacksonville, FL 32259.

ARTICLE IV. PURPOSES The purpose of the corporation is as follows:

- A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. The specific purposes of this corporation are organized for religious educational purposes which include, but are not limited to: (1) the establishment and operation of an independent private system of Christian elementary and secondary schools across the country; (2) the support, administration, and development of an independent and private educational opportunity for all persons through private Christian educational institutions and home study courses which are committed to teaching moral, ethical, and spiritual development of students as well as literacy, good citizenship training, and physical fitness; and (3) providing an environment where families can more effectively cultivate Biblical qualities of Character in every facet of life.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. The Corporation shall be authorized and empowered to pay reasonable compensation to its members, directors, or officers for services rendered, and to make payment and distributions in furtherance of its stated purposes.

ARTICLE V. MANNER OF ELECTION The Board of Directors shall be elected or appointed as described in the bylaws.

ARTICLE VI. INITIAL BOARD OF DIRECTORS The initial Board of Directors shall have three members whose names and addresses are as follows:

ARTICLE VII. INITIAL REGISTERED AGENT AND OFFICE The initial registered agent is Karla A. Brooks and the initial registered office is 820 S. Bridgestone Ave., Jacksonville, Florida 32259.

ARTICLE VIII. INCORPORATOR The name of the incorporator is Karla A. Brooks and the address is 820 S. Bridgestone Ave., Jacksonville, FL 32259.

ARTICLE IX. GEOGRAPHICAL AREA The corporation is organized (and shall be operated) in the entire United States of America, and may operate separate classrooms in such area and in such locations as it may deem necessary or advisable under such rules and regulations as specified in the By-laws.

ARTICLE X. BY-LAWS The Board of Directors shall at its first meeting, and by a majority vote, form the By-laws of the corporation.

ARTICLE XI. AMENDMENTS

Section 1. Amendments to these Articles of Incorporation may be proposed by any voting member of the corporation who submits the same in writing at any regular or special membership meeting.

Section 2. Amendments to these Articles of Incorporation may be adopted by a majority vote of the voting members present at any regular membership meeting after proper notice is given.
