ARTICLE I - NAME

The name of this Corporation is **COMMUNITY HOPE, Inc.** The mailing address is:
P. O. Box 541556, Opa-Locka, FL 33054.

ARTICLE II- DURATION

This Corporation shall exist perpetually commencing on the date these Articles are filed.

ARTICLE III- PURPOSE

The purposes for which the Corporation is organized are exclusively charitable, scientific, literary, and educational with the meaning of section 501[c][3] of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

This Corporation is not-for-profit and is organized for the purpose of providing care for the spiritual needs and the psycho-social needs of persons infected, affected with HIV/AIDS and their significant others. The corporation will deal with the multi-faceted spectrum of the AIDS disease, which includes, but is not limited to, substance abuse, incarcerated persons, and the homeless. The Corporation will be operated in accordance with the laws and statues of the State of Florida.

This Corporation shall have all the corporate powers enumerated in the Florida General Corporation Act.


ARTICLE IX - AMENDMENT

Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office if the corporation is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
